Sehr geehrte Damen und Herren, Ladies and Gentlemen

Wir freuen uns, Ihnen mitteilen zu können, dass Hupac und SBB Cargo International nach weiteren Überlegungen beschlossen haben, die in der ‚Roten Liste‘ aufgeführten Gefahrgüter auf den meisten Relationen wieder zuzulassen, mit Ausnahme einiger Schienenverbindungen, bei denen die Schienentraktion von Mercitalia Rail durchgeführt wird.

Als Anlage finden Sie eine Übersicht mit den Details betreffend:

- ADR/RID Gefahrgüter, die bei Verkehren im Hupac - Netzwerk zugelassen sind
- ADR/RID Güter, die weiterhin, z. T. auf bestimmten Relationen, nicht zugelassen sind (z.B. Ethylenoxid und Chlor). Aufgeführt sind auch diejenigen, die generell nach dem RID für den Schienenverkehr verboten sind.

Untenstehend finden Sie die Verbindungen, **auf denen weiterhin die ‚Rote Liste‘ unverändert Gültigkeit besitzt.**

We are pleased to announce you that, after further considerations, Hupac and SBB Cargo International have decided to re-admit the banned dangerous goods on most connections, with the exception of some rail connections, where the rail traction is carried out by the company Mercitalia Rail.

Herewith enclosed you will find a file with the details regarding:

- ADR/RID goods re-admitted in Hupac's network
- ADR/RID goods still excluded in Hupac's network (like Ethylenoxid and chlorine), but also those who are forbidden in railway traffic by the RID.

Please find below the connections in Hupac's network, where the transportation of such ADR/RID goods on "Red List" is still excluded:

- Rotterdam - Verona and vice versa
- Rotterdam - Brescia and vice versa
- Singen - Brescia and vice versa
- **Busto - Pomezia and vice versa - Overall from/to Pomezia**
- **Busto - Bari and vice versa - Overall from/to Bari**
- Busto - Barcelona and vice versa
